PERMIT PACKET

CHECKLIST

NOTE: Manufactured Mobile Home permit applications cannot be submitted online and must be submitted in person.

Please complete the entire application package, including:

- Permit Details Form
- Plat Copy of approved recorded plat
- Site Plan (1 Copy 8 ½ x 11 required)
 - Actual dimensions of property
 - Size and location of building on property showing distance from property lines
 - Driveway location
 - Location of any existing structures on property
 - Porch and deck located on mobile home
- Proof of Water
 - Water meter purchase receipt
 - Well Affidavit (provided by Permit Technician at time of permitting)
- Required Installation Documents
 - Mobile Home Installer: Copy of current State License and current Business License
 - If not the applicant, provide Notarized Authorized Agent Form.
 - **Sub-Contractor Affidavits:** Electrical and Plumbing affidavits must be signed and Notarized. Provide copies of current Business License.
- Owner/Contractor Documents
 - Self-Work Affidavit: Property owner may obtain permit in their name with the submission of the Self-Work Affidavit. This exemption does not exempt the Licensed Mobile Home Installer requirement. Licensed Mobile Home Installer requirements listed above remain.
- Mobile Home Placement Letter to verify zoning and acreage of property (provided by Permitting Technician to be carried to the Tax Assessors office when applying for the mobile home decal).
- Ad Valorem Tax Receipt to be provided by Tax Commissioner's Office (to replace a mobile home a
 tax receipt showing paid taxes on old mobile home is required at time of permit).
- **Environmental Health Approval** Required if on septic. Obtain at Forsyth County Environmental Health Department (770-781-6909) prior to applying for building permit.

- **Fees** Building Permit Fee: \$93.75. Impact Fees can be found on the Forsyth County Finance Department website: https://www.forsythco.com/Departments-Offices/Finance/Impact-Fees
- **Payment methods:** Cash, check, Visa, or Mastercard. Make checks payable to Forsyth County Georgia.
- Please attach elevation drawings or photos of the manufactured/mobile home.

GENERAL INFORMATION

For information concerning mobile home placement requirements in Forsyth County see the Unified Development Code of Forsyth County - Chapter 16

Mobile Home Permits are issued for replacement of older Mobile Homes and/or installation of new Mobile Homes. Mobile Homes are only allowed in certain zonings.

Required Forsyth County Building inspections are as follows:

- Setback/Site Location
- Final Plumbing Water supply connection.
- Final Electrical Meter base on structure prior to power company connection.
- Final Building Tie downs, decks, porches, underpinning, etc.
- **Required Forsyth County Building inspections can be scheduled online via the CSS Portal or by calling our Inspection Scheduling Team at: (770)781-2114 Option 1**

An Architectural Inspection will be required to check exterior wall materials and finishes. Power cannot be connected until Final Building Inspection is completed and Certificate of Occupancy has been issued.

All site plans and permit cards are to remain on site until a Certificate of Occupancy has been obtained

approved under the original hardship or age exception. A manufactured/mobile home placed					
pursuant to a Hardship Exemption may not be rented to another individual once the condition					
justifying the hardship condition is alleviated. The director shall order the removal of a					
manufactured/mobile home in cases where the director finds that no hardship continues to exist, or					
manufactured/mobile home in cases where the director finds that no hardship continues to exist, or the unit is no longer occupied by an elderly relative, in which case the owner of real property shall


