Chairman Luth called the meeting to order at 9 a.m.

A. Discussion of future challenges pursuant to Georgia Election Code O.C.G.A. 21-2-229 and O.C.G.A. 21-2-230

Director Smith asked the board to consider a hearing date for any challenges pursuant to O.C.G.A. 21-2-229 submitted by Tuesday, July 23, 2024.

Vice Chairman Natt with a second from Secretary Radzikinas made a motion that any challenges pursuant to O.C.G.A. 21-2-229 submitted by July 23, 2024 would be heard at the August 6, 2024 regular meeting. Motion carried unanimously.

V. Hearings Pursuant to Georgia Election Code O.C.G.A. 21-2-229

Chairman Luth asked if any person in the audience had received a challenge letter. There were four people in attendance who had received a letter

Vice Chairman Natt with a second from Chairman Luth made a motion to dismiss the challenge for all voters in hearings A. through H. who are in cancelled status, which includes moved out state, and those voters who have moved out of Forsyth County. Motion carried unanimously.

Item moved up on the agenda:

H. July 1, 2024 Wilson Challenge (3 names on the list)

1. Hear challenges to the qualifications of voters and their eligibility to vote pursuant to Georgia Election Code 21-2-229

There were 2 voters dismissed from the challenge: (*Motion was taken previously.*)

Voter #1 Michelle Morales Voter #2 Sydney Morales

Vice Chairman Natt with a second from Assistant Secretary Tucker made a motion to submit into the minutes any evidence submitted and the list of challenged voters. Motion carried unanimously.

Vice Chairman Natt with a second from Secretary Radzikinas made a motion to also submit into the minutes the additional information provided by staff. Motion carried unanimously.

Challenger Wilson was present. She stated she presented the challenge for the person who lives at the address of the challenged voter, Ms. Davis. Ms. Davis said she has lived at the address of the challenged voter since 2018.

Chairman Luth with a second from Assistant Member Tucker made a motion to uphold the challenge and remove from the rolls voter #3 Fernando Morales-Garcia.

Challenger Wexler was present. She stated she does not know anyone on the challenged list and does not use Eagle AI or ID3 for her research. She said she used the February 28, 2024 voter roll from the GA Secretary of State's Office (SOS) and used tax assessors' websites, tax records, court records, traffic citations and some social media.

Assistant Secretary Tucker read Section 8 2(B) Subsection D of the National Voting Rights Act and read excerpts of an NBC News report. She stated she will be voting no to uphold the challenges and remove voters from the rolls.

Challenged voters Sonia Spailier-Wittel and Frederick Wittel were in attendance and stated they currently reside at the challenged address.

Vice Chairman Natt with a second from Assistant Secretary Tucker made a motion to dismiss from the challenge voter #23 Sonia Spailier-Wittel. Motion carried unanimously.

Assistant Secretary Tucker with a second from Vice Chairman Natt made a motion to dismiss from the challenge voter #25 Frederick Wittel. Motion carried unanimously.

The board continued discussion of the remaining names on the challenged list.

2. Hear challenges to the qualifications of voters and their eligibility to vote pursuant to Georgia Election Code 21-2-230 (postponed from July 2, 2024)

The board discussed the remaining names on the challenged list pursuant to O.C.G.A. 21-2-230.

Assistant Secretary Tucker with a second from Vice Chairman Natt made a motion to recess at 10:17 a.m. until 10:30 a.m. Motion carried unanimously.
